**Show Date: November 3, 2007**

**Rules:**

1. This show will be governed by the latest revised rules of the ARBA. Filing an entry indicates acceptance of these rules and the ones listed below.
2. Neither the CFRBA or the Coastal Carolina Fair will be responsible in case of fire, accident or providential destruction; however, every precaution possible will be taken to safeguard the rabbits.
3. This is a carrying cage show. Please make your rabbits as comfortable as possible. All carriers must be leakproof.
4. All rabbits must be permanently and legibly earmarked and be the bonafide property of the owner.
5. The CFRBA reserves the right to substitute or add judges as the conditions require.
6. Judging will start at 9:00 AM, Saturday, Nov 3<sup>rd</sup> All entries must be in the showroom no later than 8:30 AM.
7. Each class will be called twice and then judged. It is your responsibility to get your rabbits on the show table.
8. Anyone indicating ownership of a rabbit on the judging table, or harassing the judge, will be disqualified and all entry fees and winning will be forfeited.
